### **Terms & Conditions**

- 1. Eligibility**  
Singapore Retail Festival x Wisma 2026 promotion is open to all shoppers, except employees of the organiser, sponsors, advertising agencies, tenants of Wisma Atria, and their immediate families.

Members must scan their in-app QR code at the point of purchase using terminals located at participating stores within Wisma Atria. A minimum spend of **\$20 per transaction** is required. There is no limit to the number of scans per day.

Rewards will be credited to the member's in-app wallet upon verification and approval of the same-day qualifying transactions.
